**IMPORTANT DATES AND DEADLINES**  
**FOR ORANGE COUNTY TAXING AUTHORITIES**

The following are important tax roll dates and deadlines related to the 2017 Orange County tax roll. Some dates may be subject to change with or without notice. If you have any questions, please contact Roger Ross, Director – Tax Roll, Customer Service & Exemptions at (407)836-5074.

**JUNE**

- 1 · The “Best Estimate of Taxable Value” letters for 2017 distributed to all taxing authorities
- 15 · System cut-off for non-OCPA users except OC special taxing & mandatory refuse – 5pm
- 16 · System cut-off for OC special taxing & mandatory refuse, 2017 Preliminary Tax Roll – 12 noon
- 20 · Delivery of DR420’s with preliminary tax roll values and supporting docs to all taxing authorities
- 26 · OCPA system active at 8am for all non-OCPA users

**JULY**

- 3 · Deadline for cities/CDD’s/drainage districts to provide all special assessment information for TRIM’s
- 27 · System cut-off for non-OCPA users except OC special taxing & mandatory refuse – 5pm
- 28 · System cut-off for OC special taxing & mandatory refuse, 2017 TRIM Notices, 12 noon
- 28 · Proposed 2017 millage rates, DR420’s and supporting docs, due to Property Appraiser by 12 noon

**AUGUST**

- 15 · “Notice of Proposed Property Taxes” in the mail to all taxpayers

**SEPTEMBER**

- 5 · First day a hearing to adopt a tentative budget may be held
- 15 · Deadline for annexations to OCPA for processing which qualify for 2017 tax roll
- 15 · Deadline for taxing authorities to certify final non-ad valorem assessment roll to Property Appraiser
- 18 · Deadline to file a petition to the Value Adjustment Board
- 21 · System cut-off for tax bills for non-OCPA users except OC special taxing & mandatory refuse – 5pm
- 22 · System cut-off for tax bills for OC special taxing & mandatory refuse – 12 noon
- TBD · Value Adjustment Board certifies 2017 Orange County final tax roll

**OCTOBER**

- 2 · Delivery of DR422’s with final tax roll values and supporting docs to all taxing authorities
- 5 · Deadline to return DR422’s to Property Appraiser with final millage rate – 12 noon
- 13 · Property Appraiser certifies 2017 Orange County final tax roll to the Tax Collector for collection of taxes

**NOVEMBER**

- 1 · Tax bills delivered to all property owners by Tax Collector
