## **2012 IMPORTANT DATES AND DEADLINES FOR ORANGE COUNTY TAXING AUTHORITIES**

The following are important tax roll dates and deadlines related to the 2012 Orange County tax roll. Some dates may be subject to change with or without notice. If you have any questions, please contact Roger Ross, Tax Roll Manager at (407)836-5074.

### **JUNE**

- 1 · The “Best Estimate of Taxable Value” letters for 2012 distributed to all taxing authorities
- 14 · System cut-off for non-OCPA users except OC special taxing & mandatory refuse – 5pm
- 15 · System cut-off for OC special taxing & mandatory refuse, 2012 Preliminary Tax Roll – 12noon
- 22 · Delivery of DR 420’s with preliminary tax roll values and supporting docs to all taxing authorities
- 25 · OCPA system active at 8am for all non-OCPA users

### **JULY**

- 2 · Deadline for cities/CDD’s/drainage districts to provide all special assessment information to Property Appraiser’s Office Tax Roll Dept. for TRIM’s

### **AUGUST**

- 2 · System cut-off for TRIM’s for non-OCPA users except OC special taxing & mandatory refuse – 5pm
- 3 · System cut-off for TRIM’s for OC special taxing and mandatory refuse - 12noon
- 3 · Proposed 2012 millage rates, DR 420’s and supporting docs due to Property Appraiser - 12noon
- 15 - 16 · “Notice of Proposed Property Taxes” in the mail

### **SEPTEMBER**

- 3 · First day a hearing to adopt a tentative budget may be held
- 14 · Deadline for annexations to OCPA for processing which qualify for 2012 tax roll
- 14 · Deadline for taxing authorities to certify final non-ad valorem assessment roll to Property Appraiser
- 21 · System cut-off for OC special taxing & mandatory refuse for tax bills – 12 noon
- TBD · Value Adjustment Board certifies 2012 Orange County final tax roll

### **OCTOBER**

- 1 · Delivery of DR 422’s with final tax roll values and supporting docs to all taxing authorities
- 3 · Last day a hearing to adopt a final budget may be held
- 4 · Deadline to return DR 422’s to Property Appraiser with final millage rate – 12 noon
- 15 · Property Appraiser certifies 2012 Orange County final tax roll to the Tax Collector for collection of taxes

### **NOVEMBER**

- 1 · Tax bills delivered to all property owners by Tax Collector
